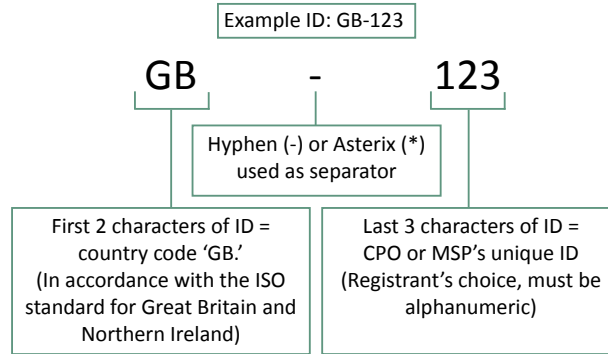

5. Cost of IDs

On application you will be required to pay a one-off registration fee of £100. You will not need to pay this fee again should you wish to register additional IDs.

You will also be required to pay an annual fee of £250 for every unique ID we issue you with. Should you wish to use the same ID for CPO and MSP you will be charged one annual fee of £250. If you would like different IDs for CPO and MSP, you will be charged an annual fee of £250 per ID.

Once we have received your completed application form we will send you an invoice for the requisite amount and confirm the ID(s) you have requested.

If, in future, you ask us to make any changes to your registered ID(s), you will be required to pay £100 for each request.

If you want to register more than one CPO or MSP ID, please complete a separate application form for each ID.

We will automatically send you an invoice for your annual fee each year unless you terminate your ID registration(s) in line with the Terms set out in Section 6, below.

All fees are shown exclusive of VAT.

6. Other terms

You agree that:

- it is your responsibility to ensure that the data provided above is correct;
- your chosen ID will be decent and will not be offensive or abusive;
- it is your responsibility to check that your chosen ID does not infringe any intellectual property laws;
- Renewable Energy Assurance Ltd will not be liable for any consequences that might flow from the ID you have chosen; and
- you will not sell or otherwise transfer your ID to any other organisation without express written permission from Renewable Energy Assurance Ltd.

Should you wish to terminate this agreement at any point, you will give us three months' notice in writing. At the end of this period we will remove your registered ID(s) from the EV Roam register. Should you terminate this agreement, any funds already paid will be non-refundable.

We will:

- allocate IDs on a first come, first served basis; and
- remove any ID from the EV Roam register in the event that registration is not kept up-to-date for any reason.
